Take control of your living legacy.

By giving appreciated securities instead of cash, you maximize your giving to nonprofits instead of paying capital gains tax. Consider a planned gift that makes the Foundation the beneficiary of some or all of your IRA, so you can give more while reducing tax burdens on your heirs. If you're 72 or older, you can use your IRA's required minimum distribution (RMD) to create a designated, field of interest or scholarship fund. If RMDs aren't required, consider giving from your DAF to support these issues.
